At a called meeting of the Cumberland County Board of Supervisors held at 9:00 a.m. on the 16th day of February 2011 at the County Administration Conference Room, Cumberland, Virginia:

Chairman Petty called the meeting to order and the County Administrator called the roll.

The purpose of the meeting was to conduct a budget work session and other items of business.

Staggered Terms

The County Attorney reviewed the Board's options for initiating staggered terms for the Board of Supervisors. He pointed out that redistricting of the election districts must be completed this year and submitted to the Department of Justice for approval prior to elections being held. Approval for staggered terms must also be received from Department of Justice, which could potentially be delayed due to the time required for the redistricting process. The Board discussed the options of holding a referendum, adopting an ordinance to initiate the process, or delaying staggered terms. After much discussion, the Board agreed to seek input from the School Board prior to taking action, since the School Board would also be elected to staggered terms, if it is put into place.

Request for Supplemental Appropriation

The Clerk of Court submitted a written request for supplemental appropriation due to the fact that an employee will be on sick leave for a period of 4-6 weeks.

On a motion by Mr. Womack and carried, the Board approved a supplemental appropriation in the amount of \$3,000 for the Clerk of Circuit Court for FY 2010-11.

RFP – Trash Disposal Services

Mrs. Matthews, Asst.
