Lighting at Randolph Volunteer Fire Department

The Board discussed the need for additional lighting in the parking area at the Randolph Volunteer Fire Department. The Auxiliary has available funds totaling \$7,000 to be used for parking lot lighting at the facility. The project cost was originally estimated at \$15,000 including installation of two metal poles with two lights on each. An alternative project cost of approximately \$7,500 was discussed to include use of six lights mounted on wooden poles that the county would purchase. There would also be a need to include concrete islands around any lighting poles.

It was the general consensus of the Board to move forward with presenting a proposal to the Randolph Fire Department and Auxiliary for approval of the alternate option with county staff providing labor and oversight of the project. Mr. Oertel and Mr. Womack volunteered to represent the Board of Supervisors in said meeting.
